



## **MERGER NOTICE NO 3: 2026**

### **THE PROPOSED PURCHASE AND SALE OF PLOT 22126 GABORONE WEST, EXTENSION 14, FROM GIFTED SUCCESS INVESTMENTS (PTY) LTD BY RALS (PROPRIETARY) LIMITED**

Pursuant to section 49(1) of the Competition Act 2018 (the “Act”), the Competition and Consumer Authority (“the Authority”) has received a merger notification for the proposed purchase and sale of plot 22126 Gaborone West, Extension 14 (“Target Enterprise”), from Gifted Success Investments (Pty) Ltd (“Gifted Success” or the “Seller”) by RALS (Proprietary) Limited (“RALS” or the “Acquiring Enterprise”).

The Acquiring Enterprise, RALS, is a company incorporated in accordance with the Laws of Botswana. It is controlled by Rajab Bengali Ammar, Hasnain Abdulrasul Bhojani, Sajida Bhojani, Chandrankant Ramkrishma Dhure and Ashokkumar Parmatma Mishra. RALS is retail wholesale in the distribution of rice, spices, beans, oil margarine to retail customers in Botswana. The Acquiring Enterprise does not directly or indirectly controls any enterprises in Botswana.

The Directors of RALS are Rajab Bengali Ammar, Hasnain Abdulrasul Bhojani, Sajida Bhojani, Chandrankant Ramkrishma Dhure and Ashokkumar Parmatma Mishra.

The Target Enterprise is owned by Gifted Success a company incorporated in accordance with the Laws of Botswana. It is wholly owned by Ananda Padmanabhan Rangaswamy. Gifted Success is a property investment company, and owns commercial, residential, farm and Industrial properties, including plot 22126 Gaborone West, Extension 14 (“The Target Enterprise”).

The Directors of Gifted Success are Ananda Padmanabhan Rangaswamy and Bianca Fazila Rangaswamy.

According to section 50 (3) of the Act, “any person, including a third party not a party to the proposed merger, may voluntarily submit to the investigator or the Authority any

document, affidavit, statement or other relevant information in respect of a proposed merger.” The Authority therefore seeks any stakeholder views for or against the proposed merger, which may be sent within 10 days from the date of this publication to the following address:
